

# PART II-B 2015 OPERATION "DO THE MATH"



**WHERE DOES THE US GOVERNMENT HIDE ALL THE STATISTICAL INFORMATION AND CRIMINAL CATEGORIES FOR THE 'MOST PRESSING ISSUE OF OUR TIME'- "HUMAN/ SEX TRAFFICKING AND MODERN DAY SLAVERY"? WHERE OH WHERE CAN THEY BE?**

THERE ISN'T A DAY THAT GOES BY IN WHICH THE TOPIC OF 'SEX TRAFFICKING' IS NOT FRONT AND CENTER IN THE PRINT AND ONLINE MEDIA. MAGAZINES, NEWSPAPERS, BLOGS- EVERY SINGLE ONE OF THEM HAS SOME SORDID STORY RELATING TO THE 'CAUSE DU JOUR'- THE '**END THE DEMAND**' CRUSADE- TO STOP ALL FORMS OF HUMAN TRAFFICKING, BY WHICH THE POLITICIANS AND THE MEDIA MEAN '**ABOLISH PROSTITUTION AND PORNOGRAPHY.**' THE OTHER LABOR TRAFFICKING GETS SHORT SHRIFT BECAUSE IT ISN'T SEXY AND NO ONE SEEMS TO CARE.

WITH ALL THE INTEREST IN THIS ISSUE, YOU WOULD THINK THAT THERE WOULD BE A SEPARATE CRIMINAL CATEGORY FOR "HUMAN TRAFFICKING" OR "SEX TRAFFICKING" BUT THERE ISN'T- AT LEAST NOT AT THE STATE LEVEL WHEN IT COMES TO REPORTING CRIMES AND ARRESTS FOR CRIME. AND THERE ARE NO SEPARATE CRIMINAL CATEGORIES FOR "PANDERING" OR "PIMPING" OR WHATEVER OTHER (USUALLY FELONY) PROSTITUTION RELATED "CRIMES" THERE ARE.

THAT'S NOT TO SAY THAT THERE AREN'T SPECIFIC LAWS RELATING TO HUMAN/ SEX TRAFFICKING OR PANDERING, PIMPING ETC. HOWEVER, WHEN IT COMES TO THE CRIMINAL REPORTING OF THE NUMBERS OF ARRESTS FOR VIOLATING THOSE LAWS, THERE IS NO SEPARATE ACCOUNTING. SUCH ARRESTS ARE LUMPED IN WITH THE "PROSTITUTION AND COMMERCIAL VICE" CATEGORY- WHICH DOESN'T SHOW WHAT PERCENTAGE OF THE (2015) ARRESTS FOR PROSTITUTION AND COMMERCIAL VICE- **[34,240- OF WHICH WE KNOW FROM PAGE 5 IN PART VI, 20,179 WERE FEMALES AND FEMALES UNDER 18 THERE WERE 334]** WERE FOR PANDERING, PIMPING OR SEX TRAFFICKING- OR IF THOSE

ARRESTS WERE PRIMARILY FOR BEING AN ALLEGED PROSTITUTE/ 'VICTIM.'

IF THERE IS NOT A SEPARATE CRIMINAL CLASSIFICATION FOR REPORTING THOSE CRIMES TO THE FBI FOR THEIR ANNUAL REPORT "**CRIME IN THE UNITED STATES,**" HOW DO WE KNOW WHAT THE NUMBER OF ARRESTS ARE FOR THOSE CRIMES? WHEN THE 'VICTIM PIMPS' AND GOVERNMENT AGENCIES CITE THE 'GUESSTIMATED NUMBER OF SEX TRAFFICKING OR OTHER LABOR TRAFFICKING, **WHAT NUMBERS ARE THEY CITING?**

## **WHERE CAN THOSE NUMBERS BE FOUND?**

WE HAVE NO ANSWERS AND DO NOT KNOW WHO DOES. THE GOVERNMENT, THE PROSTITUTION ABOLITIONISTS AND THE 'VICTIM PIMPS' HAVE NO INCENTIVE TO MAKE SUCH INFORMATION AVAILABLE TO THE GENERAL PUBLIC. IT IS ALL ABOUT PROMOTING THE '**END THE DEMAND**' AGENDA. FACTS DO NOT MATTER WHEN YOU WANT TO IMPOSE YOUR MORAL OR SOCIAL VALUES ON OTHERS.

AS LONG AS THEY CAN PROJECT UNSUBSTANTIATED 'GUESSTIMATES' OF 'VICTIMS' AND THE MEDIA ASKS NO QUESTIONS- WE WILL NEVER KNOW.
