# Sexual Deviance Behind the Badge

#### **ABSTRACT**

The number of registered sex offenders is increasing at a dramatic rate. In fact, since the last survey conducted by the National Center for Missing and Exploited Children in 2006, the number of registered sex offenders increased over 23 percent (National Center for Missing and Exploited Children, 2012). Tracking nearly threequarters of a million sex offenders is an added burden to the legal system. Law enforcement personnel come into contact routinely with these offenders, and often have to deal with the devastation they leave behind. Working with vulnerable populations leave many officers wondering how someone could hurt a child. Compounding the hurt is betrayal, when officers realize a fellow officer, partner, or friend has been arrested for a sex crime especially when the crime is against a child. The crime is heinous enough, but officers and their agencies are also victims. They are victims to the lies and deception. Some officers know of indiscretions by fellow officers and will turn a blind eye. Many more question how a sex offender ended up on the force, considered one of them and no one was aware.

# Sexual Deviance Behind the Badge

A sex offender is defined as an individual convicted of a sex offense (Cornell University Law School (n.d.). Sex offenses are further distinguished as either *forcible* or *non-forcible*. Forcible sex offenses include sexual offenses committed forcibly against one's will. Non-forcible sex offenses include offenses "... against the person's will where the victim is incapable of giving consent because of his/her temporary or permanent mental or physical incapacity (or because of his/her youth)" (Medical College of Wisconsin, 2012, p. 1).

According to the National Center for Missing and Exploited Children (NCMEC) approximately 747,408 sex offenders were registered nationwide to date (2012). This is an increase from 2011, by 7,555 offenders (NCMEC, 2012). The last survey conducted by NCMEC was 2006 and since that survey, over 140,000 more individuals were added to the list. The current number of registered sex offenders in the United States (including the District of Columbia, American Samoa, Guam, Northern Mariana Islands, Puerto Rico, St. Croix, St. John, and St. Thomas) topping nearly three-quarters of a million (U.S. Census Bureau, 2010). In addition, numbers as high as 100,000 and as low as 25,000 have been thrown around regarding to the number of "non-compliant" sex offenders in the US (Harris & Levenson, 2011; NCMEC, 2012).

According to the Illinois State Police, a sex offender is deemed "non-compliant" when they fail to 1.) "Register with the local law enforcement agency within 3 days of notification by the Illinois Department of Corrections or the Court; or 2.) Register annually; or 3.) Register quarterly (if applicable); or 4.) Provide complete and accurate information to law enforcement personnel during registration; or 5.) Change his or her address or other information without notifying law enforcement personnel" (2012). As one can imagine, keeping up with the ever-increasing number of sexual offenders and their ability to relocate have become a full-time job for those in the legal system.

Much time, energy, and money is spent on housing individuals sent to prison for sex-related crimes, state and federal sex offender registries, compliance officers (e.g., parole, probation, and

law enforcement officers), and monitoring systems for at-risk offenders. A huge disadvantage with these types of offenders is in the inability to develop a clear composite or profile of the "typical" sex offender. However, a similarity found in the majority of sex offenders is that they are male. An accurate composite remains unavailable due to the numerous variations found in each offender.

Regardless of the unique qualities of each offender, certain information should be considered when working with this population (e.g., family environment, mental health concerns, existing emotional issues, relationships between offender and victim, and rates of recidivism for some offenders). Sex offenders exist within all demographics of society. And though we as a society want to believe we can pick out these monsters, the truth remains, we cannot. Those who are able to reoffend know how to conceal their behaviors and they know how to stay below the radar.

Occupations receiving a majority of media attention regarding sexual crimes and deviance include those in the clergy and teachers. Other positions, which receive attention, include coaches and scout leaders (Neddermeyer, 2012). These individuals are trusted to care for and protect our children. They are supposed to set the example for good behavior and doing what is morally, ethically, and spiritually right. However, are these really the worst offenders, or does the media make it appear that way? Is this a fair and accurate assessment? According to Bassler (2011) police officers account for a higher percentage of sex offenses than do teachers or clergy members.

Most officers would probably agree that one of the most despised crimes they encounter are sex crimes against children. Crimes involving children are difficult to deal with for many because they, too, have children and children are considered a vulnerable population. Most cops take crimes against children personally. The thought of an officer's own child being abused in these ways is beyond comprehensible.

How can the number of police officers arrested and charged with sex crimes be explained? (see APPENDIX A). Appendix A is not a complete list of law enforcement personnel charged with sex offenses, however, the list shows that there is enough of an issue to deem it worthy to address. As with many child sex offenders, the process of grooming makes this more understandable. Grooming involves gaining the trust of parents and guardians. This can be easily accomplished if one is a police officer, as society places a great deal of trust in them. Take the

case of former officer Dan Hiers. Hiers befriended a young, single mother in a local karate class. Hiers initially seemed like the perfect role model for the young girl, who desperately needed a male figure in her life. This could not have been any further from the truth. After gaining the mother's trust, Hiers groomed the young girl and eventually molested her. Hier is a fugitive on the run, not only for molesting this young girl, but also for the murder of his wife. Neddermeyer (2012) explained:

"As a society we vehemently condemn stranger child sex offenders, but when someone we know is suspected or accused, many people take sides often refusing to believe that 'a pillar of the community' could commit this type of a crime." (p. 2)

According to the National Police Misconduct Statistics and Reporting Project (3<sup>rd</sup> Quarter Report) "police officers were accused of sexual assault at a rate of 79 per 100,000 law enforcement personnel. That is well over two times the rate in the general public (28.7 per 100,000)" (as cited in Carter, 2011). Again, we see cases of officers who are supposed to serve and protect acting like criminal offenders. When a police officer is accused or charged with a sex offense, many are stunned.

In another case, a former Modesto, California officer was indicted by a grand jury for felony sex acts with an adult female. This officer was acting in the capacity of his duties and on-duty at the time of the incident. The Modesto Police Chief explained his disappointment and disgust with the former officer's actions, further stating that this officer's actions were abhorrent and not representative of the dedicated staff who work tirelessly to serve the community" (CBS Modesto, 2012). Officers who commit crimes, hoping to be shielded by the badge are not an honest reflection of the force as a whole. The difficulty lies in the fact that the police are seen collectively, rather than individually. Cops by nature turn to dark humor and often have senses of humor, which can be outside the norm. A sex offender can virtually hide behind the badge, gaining almost immediate trust with parents. The grooming process may or may not be much easier for someone given a great degree of public trust. Sex offenders are chameleons. They will do what it takes to get what they want. These master manipulators do not just fool innocent children and families, but fellow officers.
