A girl who says a corrupt NYPD detective put her on the street when she was a 13-year-old runaway and forced her to work as a prostitute has filed a \$25 million law suit.

The suit accuses Wayne Taylor, a former city narcotics detective of pimping out the Brooklyn youngster and taking money from men who wanted to have sex with her.

The Brooklyn federal court lawsuit, which names the city, the NYPD and the officer, was filed by the girl, who is still a minor, and her mother. The Post is withholding their names.

The cop told the girl that she had been "sold" to him for \$500, and then he forced her to dance naked at parties and service adult men in Jan. 2008, the suit says.
