

## Fort Hood soldier pimped out soldiers, set up sex parties

He was supposed to prevent sexual assaults in the Army.

Instead, he pimped out cash-strapped soldiers at Fort Hood to make some extra money — all to his wife's knowledge, according to a report.

Gregory McQueen, a former sexual assault prevention officer, made headlines when he was arrested for persuading at least two women to join his Texas prostitution ring two years ago.

The 39-year-old's sexploits are now out in the open. He pleaded guilty Thursday to 15 charges, including for recruiting prostitutes.

Not only did McQueen bring the poor women into his filthy clutches — making at least one prove her skills in the boudoir by having sex with him — but he also sold their services at kinky sex parties he organized for higher-ranking officers, according to documents obtained by The Daily Beast. He also kept naked pictures of his prostitutes to show off to potential clients.

McQueen, a recreational gospel band saxophonist, was financially strapped, according to a report by the U.S. Army's Criminal Investigation Command.

His wife, Sherita, whom he affectionately called, "Rita Rita Pumpkin Eater," nagged him about bills. McQueen briefly — for about a week — tried working as a suit salesman at the local Killeen mall to pick up extra cash.

His wife must have known about his pimp side job, based off of texts he sent her about "clients," according to the report. He also sent a picture of a female soldier from the Bronx, calling her a "Hood Chick."

Sherita had "issues with (McQueen) prioritizing pleasure over financial priorities," according to the report.

Soon after McQueen recruited his first female soldier — a single mother who needed to buy groceries for her 3-year-old — she started helping him bring in other cash-strapped female soldiers, including a woman who worked under McQueen and another who stripped at a local club.

McQueen was aggressive in his recruiting tactics. In 2013, he plied the soldier under his command with alcohol to try to make her have sex with him and "show me what you can do," according to The Daily Beast.

When she refused, he had his first recruit take the woman's hand to help her masturbate.

"What are your limitations?" the first recruit asked of the woman's prostitution prospects.

"Because sucking d--k is the money-maker."

Against the woman's wishes, McQueen began kissing her on the neck and between her legs, even though he knew she had already been made a sexual assault victim by a sergeant during her first year of army training.

"It makes me feel like I had been sexually assaulted again," she said, ultimately refusing to join the ring.

McQueen later pleaded guilty to battery for the attack.

The women in the ring said they made between \$400 and \$500 per session with a john, but McQueen offered them up to fellow officers for cheap, according to the report.

"I have a female that will do anything you want for \$75," McQueen told a sergeant. "I know you are single so I wouldn't need to find a place for you. If you are interested, let me know."

McQueen didn't set up trysts only for the ladies in his ring. He organized a "gang bang" between a woman and four officers as her husband watched.

"They are cool with the gang bang and (your husband )watching but they are all seniors in the military and worried about video and pics," McQueen said in a text, asking her to make sure her husband left his camera at home.

McQueen was into kinky things, too, asking the same woman to engage in "choking," "biting," "spanking," "ruff f---ing" and domination, according to the report.

His sleazy endeavors clearly took up most of his energy, judging by the fact he made no sexual assault reports during his time as a noncommissioned sexual assault prevention officer.

He was finally investigated when a friend of the woman he assaulted went to his higher-ups.

McQueen will spend two years in prison and was given a dishonorable discharge Thursday. He escaped a potential 40-year prison sentence and avoided conviction for six other charges .
